

**RESOLUTION 2022-83**

**RESOLUTION AUTHORIZING THE BOROUGH OF SOUTH RIVER TO ENTER INTO A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF EAST BRUNSWICK FOR EMS SERVICES**

**WHEREAS**, the Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., authorizes the Borough of South River to enter into a contract for various governmental services with the Township of East Brunswick; and

**WHEREAS**, N.J.S.A. 40A:65-5 requires such a contract to be authorized by resolution; and

**WHEREAS**, the Borough of South River and the Township of East Brunswick have agreed upon various terms for the sharing of the EMS services; such agreement is attached hereto and incorporated herein as Schedule A; and

**WHEREAS**, it is the desire of the governing body to authorize the execution of a Shared Services Agreement with the Township of East Brunswick to enter into a contract for EMS services with the Township of East Brunswick.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Borough Council of the Borough of South River, County of Middlesex, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a Shared Service Agreement with the Township of East Brunswick for EMS services. A copy of the agreement is attached hereto as Schedule A.
2. That the Mayor and the Borough Clerk of the Borough of South River are hereby authorized to execute and attest, respectively, a Shared Services Agreement with the Township of East Brunswick, in a form acceptable to the Borough attorney, and any other documents necessary to effectuate the terms of this resolution.
3. The term of this Shared Services Agreement shall be from February 1, 2022- June 27, 2024 subject to renewal/ extension by consent of the parties.
4. That a Certificate of Availability of Funds is attached hereto and incorporated herein. The following are the line item appropriations or ordinances which constitute the availability of funds for this contract:
5. That a copy of the agreement shall be kept on file and made available for public inspection at the Borough Clerk's Office during normal business hours.
6. That a certified copy of this resolution be forwarded to the Township of East Brunswick, the Borough Administrator and the Chief Financial Officer.
