ORDINANCE NO. 2021 – 03

AN ORDINANCE OF THE BOROUGH OF SOUTH RIVER, COUNTY OF MIDDLESEX, STATE OF NEW JERSEY, AMENDING THE BOROUGH CODE OF THE BOROUGH OF SOUTH RIVER, SO AS TO AMEND CHAPTER 295, ENTITLED “SUBDIVISION AND SITE PLAN REVIEW; STORMWATER MANAGEMENT” This ordinance amends Chapter 295, entitled “Subdivision and Site Plan Review; Stormwater Management” to revise its provisions to comply with the newly amended NJDEP stormwater rules.
